Go to <http://www.fdle.state.fl.us/Criminal-History-Records/Florida-Checks> and complete the INSTANT FLORIDA DEPARTMENT OF LAW ENFORCEMENT BACKGROUND CHECK by completing the online request and providing a credit card for the fee. The web site will provide you with a printout of the results. This is a requirement for all new members regardless of occupation or recent background checks.

1. Attach proof of completion of a firearms training class to your application. Any NRA certified firearm class, state Hunter Safety Course, concealed weapons certificate/license or law enforcement/military training will qualify. If you have not had firearms training, you can contact Matt Morris at 850 566-9730 or [lovewater.mm@gmail.com](mailto:lovewater.mm@gmail.com) to schedule a class.
2. Complete the TRPC Range & Safety Rules Test. (Provided with the New Membership Application Packet. Remove the club rules pages 15 through 19 and retain for future reference.)
3. Complete the TRPC NEW MEMBERSHIP APPLICATION and (1.) Attach proof of current NRA membership to PAGE 05 of the TRPC NEW MEMBER APPLICATION PACKET. (2.) Attach proof of completion of firearms training course to PAGE 05 of the NEW MEMBER APPLICATION PACKET (3.) Complete the TRPC Range Safety & Rules Test on PAGE 11, 12, 13, AND 14 of the TRPC NEW MEMBER APPLICATION PACKET (4) ATTACH A COPY of the FDLE BACKGROUND CHECK to PAGE 06 of the TRPC NEW MEMBER APPLICATION PACKET and RETURN THE ENTIRE COMPLETED NEW MEMBERSHIP APPLICATION PACKET TO TRPC, P.O. Box 7638, Tallahassee, FL 32314-7638 or scan and email to [secretary@trpc.net](mailto:secretary@trpc.net) .
4. Upon receipt of your completed packet, you will be scheduled for a NEW MEMBER ORIENTATION by a board member.
5. Upon completion of the New Member Orientation and payment of **\$176.00 initiation fee (\$250.00 less \$50.00 allowance for a firearms class and \$24.00 allowance for FDLE background check) + \$11.00 for each remaining full month through the next June 30 (\$130.00 maximum)**, you will be issued a MEMBERSHIP/PROXIMITY CARD. In the next 12 months you must not have ANY violations of Range & Safety Rules issued, complete 2 hours of range service (1 TRPC Range Work Day or 2 hours of Board of Directors approved service) and attend one General Membership meeting.
6. You will become a full member upon completion of the 1 year probationary requirements.

# TRPC YOUTH PROGRAM

## Monthly "2nd Saturday" Shooting Program

Date/Time: Second Saturday of each month from 8:30am until 11:00am.

Location: TRPC Range A-1 and A-2. Cost: No Charge - Open to all boys and girls 17 years old and younger. Shooters need not be associated with a club member.

TRPC supplies all safety equipment, rifles, .22-caliber ammunition and targets.

This is an excellent opportunity for youth to gain experience with shooting firearms and to develop firearm safety. We have the young shooters set up the range, giving them a chance to get to know each other. After a brief Safety and Marksmanship orientation, we shoot from 9:00am until 11:00 am.

We use the NRA 50-foot Rifle Qualification Course, which lets the shooters start at a low qualification level from a supported prone position. The course works through prone, sitting, kneeling and standing positions, requiring progressively greater levels of skill. There are awards, such as patches and/or medals (provided by the club), at each stage.

We have expanded our youth program to include shotgun shooting. The trap range is available to competitors after completion of the rifle program.

Adult volunteers are always needed.

# TRPC GENERAL RANGE AND CLUB RULES

Revised 04/12/2017

1. Shooting during daylight hours only.
2. Scheduled events take precedence over practice sessions.
3. Do not give your proximity card to anyone.
4. Absolutely no climbing on the side berms or backstops and no damaging any club property.
5. All members are responsible for cleaning up their trash and for generally policing the area where they have been.
6. One Day Member Policy (4/2010 & 10/2015):
  - One Day Members may come to the range an unlimited number of times.
  - One Day Members must pay \$10.00 each time they are on club property.
  - The spouse of a TRPC member does not pay the \$10.00 fee when accompanying the member to the range.
  - Dependent children, under the age of 18, of a TRPC member do not pay the \$10.00 fee when accompanying the member to the range.
  - The \$10.00 fee does not apply to TRPC matches or the Youth Program.
  - Participants and observers of a scheduled match or the Youth Program do not pay the \$10.00 One Day Member fee.
  - At the conclusion of the match or the Youth Program, all participants and observers must leave TRPC property.
  - All One Day Members must be accompanied and supervised by a TRPC member.
  - A TRPC member may only bring three (3) One Day Members at a time. 01/17/13
  - Spouses and dependent children of TRPC members are included in the 3 one day member's limit. 01/17/13
  - All match participants, observers, and One Day Members must sign a release of liability each time they are on TRPC property.
  - The release must be signed immediately upon entering TRPC property.
7. ALWAYS check before you leave the range to see if you are the last one there. The last one to leave the range on any given day is responsible for making sure the gate closes.
8. Every member is responsible for range safety. If you observe anyone violating the rules or behaving in an unsafe manner, you are expected to caution the individual and to report flagrant violations to the Board of Directors. Safety is the responsibility of EVERYONE ON THE RANGE.
9. No member, individual or business entity may use the range for shooting commercial purposes. The board must approve non-shooting commercial purposes.
10. All instructors conducting a class for any type of firearms will have, at a minimum, trainer certification from NRA, NROI, NMLRA, Florida Fish and Wildlife Conservation Commission (Hunter's Ed) or any agency recognized by the Criminal Justice and Standards Commission.
11. Persons giving informal training to a guest or family member (as encouraged by the TRPC Purpose as given in the Bylaws and by current NRA policy) do

- not require certification as a trainer. The only two conditions are: 1) The member providing the training must be knowledgeable in the discipline, and 2) There must be no claim that the trainee is earning any official endorsement from any organization.
12. Ranges may be scheduled for events only with prior notification in the newsletter or if approved at a regular General Membership meeting or under direction of the BOD as set out in STANDING RULE 19 (BA#010 03\_10/10/11 GMM 10/12/11). Completion of the NEW EVENT FORM is required for presentation to the board and membership. (04/12/2017)
  13. Members must wear or visibly display their membership card while on the range.
  14. The entrance gate must remain locked at all times.
  15. Everyone on TRPC property shall possess a valid, government issued picture identification and present it upon request. (01/09)

# TRPC STANDING RULES

Revised 01 10 2026

1. Memberships renew on July 1 and expire on June 30.
2. Regular membership fees are \$210.00 per year. (01/2026)
  - Members will receive an \$80.00 credit for providing 2 hours of range service. (01/2026)
  - Range service hours must be provided at a Workday or approved by the Board of Directors. • See Range Service Policy or TRPC Website. (01/2026)
3. An initiation fee of \$250.00 will be charged to all new regular & associate memberships. (07/10)
4. Junior members promoting to regular membership do not pay the initiation fee.
5. All new memberships will pay a prorated annual membership fee of \$11.00 per full month remaining through the next June 30. (01/2026)
6. Membership renewals paid after July 31 may be charged a \$10.00 late fee.
7. Members not renewing by August 15 must apply for new membership.
8. Alcoholic beverages may not be purchased with TRPC funds.
9. The current rules and by-laws will be posted at the range clubhouse. These are to be dated and signed by the president and secretary.
10. Non-consumable purchases for range supplies in excess of \$50 require approval from the vice-president.
11. Pay to do road grading for Community Road to be done as required.
12. Each renewing member must sign, date and return the TRPC liability form to the secretary.
13. All persons on TRPC property must sign a waiver of liability.
14. Applicants shall attend a new member orientation prior to receiving membership card.
15. TRPC Board of Directors has discretionary funds of \$1500 per quarter. (4/1998).
16. Members in good standing serving in the military who receive orders for deployment for a least 1 year will have their annual membership fee paid by the club. It is the members' responsibility to provide the Secretary with proof of orders. (01/2009)
17. A processing fee, based on actual cost, will be charged for:
  - 1) a returned check
  - 2) \$20.00 for a replacement membership/proximity card.
18. Any Life Member who wishes to use the range must renew his/her range privileges each year and obtain a new TRPC ID Card by completing all the paperwork required by the Board of Directors in its entirety. Life Members must strictly adhere to the By-Laws, the Standing Rules, the General Range & Club Rules, and the Range Safety Rules. (10/10)
19. When accompanied by an officer of the club, to include but not limited to, President, Vice President, Secretary, Treasurer, Board Member at Large, Match Chairman, Youth Program Director, TRPC CRSO or designated Club RSO, a group may be exempted from the one member – three guest rule for the purposes of training or match preparation. The time frame must be cleared in advance with the BOD and must not interfere with any previously or regularly scheduled TRPC match or range activity. (BA 010 03 OCT 12, 2011)

# TRPC RANGE SAFETY RULES

**Revised 0/11/2023**

1. Keep all firearms pointed in a safe direction.
2. Keep firearms unloaded until you are ready to shoot.
3. Keep your finger off the trigger until ready to shoot.
4. Every range is cold until everyone on that range agrees to go hot.
5. Eye and ear protection is required on or near the firing line when the range is hot.
6. TRPC is a cold facility. No loaded firearms may be carried on the range except for legal concealed carries and by law enforcement officers on official business.
7. Use only club provided or equivalent frames to hold targets.
8. Only rim-fire, muzzle loaders and firearms shooting pistol cartridges are allowed on the pistol ranges. Use of shotguns is permitted within a sanctioned match at non-aerial targets. Shot size not to exceed #7 ½.
9. No shot larger than #7 ½ on the trap range.
10. Use only metallic silhouettes or approved targets on the silhouette and small bore range. Only use .22 rim-fire ammunition on this range -- NO MAGNUMS.
11. No smoking within 20 feet of the firing line during muzzle loading.
12. Pets must be under direct control of the member at all times.
13. Minors and non-club members must be supervised at all times.
14. Spouses and minor children may only use the range when accompanied by and under the direct supervision of the member.
15. Guests are not permitted on the range unless the sponsoring member is present.
16. No more than three (3) guests per member are permitted at a time.
17. If you bring a guest to the range you are responsible for his conduct and for seeing to it that all RANGE and SAFETY RULES are strictly observed.
18. Make sure that any shot fired hits the backstop. Never fire into the side berms.
19. When firearms are not being used they are to be left with action open or the cylinder out.
20. While people are down range checking targets, no guns are to be handled.
21. No machine guns or fully automatic firearms are allowed on the range at any time. This rule shall preclude the use of rapid-fire trigger devices or cranks. No tracer or armor piercing ammunition.
22. Approved targets are 1) paper, 2) clay pigeons, 3) plastic jugs, if placed at the BASE of the backstop, 4) metal silhouettes on the rimfire silhouette range, and 5) steel plates in the "steel house" on Range B. 6) Dueling Tree, Texas Star, and reactive steel targets in the designated area for Cowboy Action matches on A1, 7) Steel targets constructed of a minimum thickness of 3/8" AR500 or superior quality steel no less than 12" diameter hanging in the "steelhouse" on Range D, 8) Steel targets constructed of a minimum thickness of 3/8" AR500 or superior quality steel placed on a TRPC-owned appropriately constructed swinging target hanger (for rifle targets) and TRPC-owned appropriately constructed fixed target hanger (for pistol targets) placed as close to the base of the berm as practicable on Ranges E & F. Prohibited targets are 1) glass, 2) metal cans, and 3) any other targets not listed under "approved targets".
23. No running, jumping or climbing with a loaded gun except at a sanctioned or approved event.
24. Shooting or handling firearms while under the influence of alcohol or drugs is strictly prohibited (under the influence means after recent consumption of ANY amount). Alcoholic beverages and illegal drugs are prohibited on TRPC property at all times.
25. Horseplay with a firearm is prohibited.
26. Practice safety and good sportsmanship and use common sense at all times.
27. No .50 Caliber BMG or higher power firearms are to be fired on the range.
28. Shooters must read, obey and enforce the specific rules posted at each range used.
- 29.** When TRPC members or guests use a range, they must operate the electronic range Hot Light designation system. Everyone on the range that is not changing or checking targets must remain behind the red safety line when the range is designated COLD. No one is allowed downrange when the range is designated HOT.

## **TRPC RANGE SERVICE POLICY**

1. The \$80.00 Range service credit is awarded by working one of the 5th Saturday workdays or other work assigned by a board member or match chairman.
2. Workday will begin at 8:00 AM. Members arriving after 8:30 AM will need to check in with the Vice President or other board member.
3. Members must sign-in to receive work the \$80.00 work credit. A sign-in sheet will be on the table under the shelter.
4. The Vice President will decide when the work day is completed and when ranges will be opened for shooting.
5. There is no partial credit for work day attendance.
6. Board members, match chairmen, and individuals designated by the Vice President will lead work crews. Members will be assigned to work crews upon arrival.
7. Members should bring gloves, hats or other protective equipment as needed.
8. Members who reach their 75th birthday will automatically receive the \$80.00 work credit each renewal year.
